Introduction

Industrial sector has an important and effective role in countries' economic development and contribution to gross domestic products (GDP) due to job opportunities it creates. For this reason, jointly with ministry of trade and industry especially general directorate for industrial development within ministry of trade and industry and board of investment, KRSO works to collect detail data on industrial sector through conducting survey on an annual basis. In 2018, in cooperation with ministry of trade and industry/ general directorate for industrial development, KRSO renewed the frame (list) of medium industries in Kurdistan region as a start step to conduct survey in a field work. Medium industrial establishments are separated from other industries (big and small) by the number of active employees and classification has been made based on the number of employees (10-29) not on the capital basis.

Industry surveys are supposed to be conducted on an annual basis, but it was hampered due to economic crisis that struck KRI in 2014. The last medium industry survey was conducted in 2013.

Objectives

The aim of this survey is to provide indicators, data and information on industry sector by type of industry, number of medium industrial establishments, product value, and number of employees at the level of governments in KRI. These data could meet the users' requests especially in the field of GDP.

Medium industry: it refers to industries where the number of employees and workers is between 10-29 employees.

Main Indicators

- 1. Number of industrial establishments
- 2. Number of employees
- 3. Compensations
- 4. Production value based on selling price
- 5. Total inputs value (intermediate consumption value)
- 6. Labour productivity
- 7. Country currency (ID Dinar) productivity
- 8. Annual average wages of paid employees
- 9. The average wages to value added
- 10. Product rate

Methodology

Updating the Frame of the Survey

Following opening training courses for local supervisor in governorates on 11/11/2018, updating the frame of the survey in KRI started on 12/11/2018 and lasted one month. For this purpose, enumerators visited all functioning industrial establishments, where the number of employees and workers is 10-29 employees. Medium industrial survey is an all cover survey in which all industrial establishments are surveyed.




Figure 1: No. of Medium Industrial Establishments by the New Frame at the Level of KRI and Governorates




Figure 2: No. of Workers in Industrial Establishments by the New Frame at the Level of KRI and Governorates

Based on the information received from Board investment and general directorate of industrial development on the number of industrial establishments which had been provided license, and also based on the frame available in KRSO from previous years, a new frame was designed, in which the number of industrial establishments (big and medium) was 981 establishments in KRI. Of these, 911 of establishments were visited that were functioning and the rest were permanently or temporally close due to different reasons in 2018. Of the total 911 establishments, 421 were medium establishments and the number of employees was 6,033 as presented in Figures 1 and 2.

Questionnaire

Questionnaire is an essential tool for data collection in any survey. To collect different information on the main indicators in this survey, the questionnaire contains 20 tables that have been presented in the Appendix of this report.

Training course

The process of training conducted through the following stages:

- 1. Opening course for local supervisors on 11/11/2018 for the purpose of updating the frame,
- 2. A three-day course for supervisors, enumerators, and editors in KRSO on 21/4/2019. The course was conducted by survey supervisor.
- 3. One-day training course for Supervisors and enumerators on 24/4/2019. The course was conducted by data management and analysis department to train the attendants on how to use tablet in collecting data and send data to analysis department in KRSO.

Field Work

The field work started on 10/6/2019 to directly collect information from Medium size industrial establishments. The process of data collecting lasted for two months until 10/8/2019. The number of enumerators in governorates was as follows:

- Erbil,5 enumerators, 1 local supervisor, and 1 representative form Erbil industrial development
- Duhok, 3 enumerators, 1 local supervisor, and 1 representative form Duhok industrial development.
- Sulaimani, 10 enumerators, 1 local supervisor, and 1 representative form Sulaimani industrial development.
- Garmiyan administration, 1 enumerator.
- 3 enumerators form KRSO, and a representative from Industrial development directorate visited enumerators in the field,
- 7 editors from governorates.

Obstacles faced the survey

No doubt, conducting any survey has its own problems. Like any survey, industrial establishment survey is not safe from problems especially during the field work. One of these problems which we can refer to is refusing the interview partially or completely by the owners of the industrial establishments withholding information even after several visits which delayed the process.

Data entry

Following the field work and editing the questioners, data recording started in governorates. Then the recorded data were sent to the analysis department in KRSO.

Data cleaning

To clear data from the inaccurate records or irrelevant data or identifying incomplete parts or unanswered questions, data cleaning would be done. In the case of missing answers, the local supervisors would be called to complete the missing values. The supervisors were already trained in a workshop in KRSO for these cases.

Data analysis

Data analysis was done through SPSS program in analysis department in KRSO following the process of data cleaning.

Main Results

Number of Medium Size Industrial Establishments

In KRI, 2018, the number of medium establishments recorded at 375 establishments, where it shows an increase by 106% comparing to 182 establishments in 2013. Sulaimani governorate takes the lead with 217 establishments comparing to 75 and 83 establishments in Erbil and Duhok governorates respectively.




Figure 3: No. of Medium Industrial Establishments in KRI, Comparison between 2018 and 2013

Note: the number of establishments is different between what is recorded in the frame and what is recorded in the interview due to the followings:

- 1. Not working of some of the establishments in 2018
- 2. Some establishments were not ready to work due to not being completed until 2019
- 3. Changing some activities from industrial to not industrial activities

Number of workers

The number of worker has rise in 2018 (5,401) compared to 2013 (2,488) in Medium size industrial establishments in KRI, where it shows an increase by 117%. The number of workers is 1,298 in Erbil, 2,976 in Sulaimani and 1,127 workers in Duhok governorate.





Figure 4: No. of Workers in Medium Industrial Establishments in KRI, Comparison between 2018 and 2013

Of 5,401workers engaged in medium size industrial establishments in KRI 5,050 are Iraqis, 84 are Arabs, and foreigners form 267 workers.

Compensation and wages

The total value of compensation and wages rose to 37 billion and 779 million ID in 2018 compared to 24 billion and 736 million ID in 2013 as presented in Figure 5.






Production value based on selling price


Figure 6: Production value on selling price in Medium industrial Establishments in KRI, Comparison between 2018 and 2013, Million ID

Production value on selling price recorded 560 billion and 425 million ID in 2018 compared to 287 billion and 193 million ID in 2013, Figure 6.


Figure 7: Production value on selling price in Medium industrial Establishments in KRI, Comparison between 2018 and 2013, Million ID

Consumption recorded 456 billion and 40 million ID in 2018 compared to 170 billion and 626 million ID in 2013, Figure 7.


Figure 8: Labor Productivity in Medium industrial Establishments in KRI, Comparison between 2018 and 2013, Million ID

Labor productivity with a decrease of 7% reached 107.88 million ID in 2018 compared to 115.4 million ID in 2013, Figure 8.


Figure 9: Dinar Productivity in Medium Industrial Establishments in KRI, comparison between 2018 and 2013

Dinar Productivity increased by 33% in 2018 (15.42) compared to 2013 (11.6), Figure 9

Annual average compensation decreased by 29% in 2018 (6.99 million ID) compared to 2013 (9.9 million ID).


Figure 10: Annual Average Compensation of workers in Medium Industrial Establishments in KRI, comparison between 2018 and 2013, million ID

Figure 12: Output Percentage Rate in Medium Industrial Establishments in KRI, Comparison between 2018 and 2013


